

ACCEPTED SPECIFICATION FOR A CLASS 7(c) CAR - RICKMAN RANGER

MSA Regulation **T 10** requires 'Front engine cars manufactured on a limited basis' (generally referred to as kit cars) to conform to an 'accepted specification'. This ACTC Accepted Specification, which must be read in conjunction with the current MSA Competitors' Yearbook and the current ACTC Classic Trials Series Rules and Regulations, defines the car described. All references are to the MSA Competitors' Yearbook current at the date of issue of this specification. (Tone denotes amendments from the previous version.)

T10.4.3	Luggage box	External luggage boxes are not permitted.
T 10.6.1	Cylinder blocks: Considered original for the purposes of this Regulation. MSA Rule T 10.6.1 does not apply to Class 7(c). T10.6.3	Engine mountings: Considered original for the purposes of this Regulation.	<p>Maximum horizontal dimension from the centre of the foremost spark plug orifice to a vertical line through the centre axis of the front wheels:</p> <ul style="list-style-type: none"> • Ford OHV "Kent" Series: -102mm (-4") • Ford OHC "Pinto" Series: -102mm (-4") • (Engine is in front of axle)
T10.8.2	Suspension	The original manufacturer's suspension system must be retained spring rates and shock absorbers may be changed.
T 10.9	Diameter of road wheels: Considered standard for the purposes of this Regulation.	13" or 14" only
T10.10.4	Spare wheels / luggage boxes:	<p>A single spare wheel may be carried in the standard Rickman carrier, offset to one side.</p> <p>Two spare wheels may be carried in a purpose built carrier, centrally mounted and vertically positioned, with the rear of the carrier not more than 400mm behind the rearmost chassis mount.</p>
T 10.12	Gearbox: Considered original for the purposes of this Regulation.	<ul style="list-style-type: none"> • As fitted to Ford Escort Mk1 and 2.

T **Rear axle casing:** As fitted to Ford Escort Mks1 and 2
10.12.3 Considered original for the purposes of this Regulation. MSA rule T10.12.3 does not apply to Class7(c) Modifications to the casing are not permitted.
