- 12.1 Proposed ACTC Regional Championships, Response from Fell Side Auto Club. I had already instigated early discussions with Bernie Pugh of Durham Auto Club and John Rhodes of Airedale and Pennine Motor Club over a Northern Classic Trials Championship. In principle Fell Side Auto Club supports a Northern Championship. However we have some comments to make:-
- A Northern Regional Championship must also include bikes/combinations. They are a critical part of the Northern Classic Trial and deserve to be recognised in a championship.
- There would be little benefit to a purely Northern Championship by overlapping 2 or more trials from another area. Due to the distances involved it would not then be a Northern Championship.
- Taking trials from another area could well dissuade sponsors attracted to specific trials due to it being 'Northern'.
- Although it is early days, there is a possibility of a further trial on the English/ Scottish border and it could be a single venue. This would mean that a Northern Championship could constitute 4 local trials.
- Any championship must run with minimal additional work for each individual organsing е club.
