SUPPLEMENTARY REGULATIONS

1. Camel Vale Motor Club Ltd. will organize a Clubman's Permit Classic Reliability Trial on Sunday 1st. November 2015 at Cardinham Woods, near Bodmin, Map Ref: 200/118674 (entrance).
2. The meeting will be governed by General Regulations of the Motor Sports Association. (Incorporating the provisions of the International Sporting Code of the FIA) and these Supplementary Regulations
3. Both an MSA Permit and an ACU Permit has been applied for.
4. The event is open to fully elected members of the following clubs, Launceston & North Cornwall Motor Club, Holsworthy Motor Club, Stroud & District Motor Club, Bristol Motor Club, The Motor Cycle Club, Minehead Motor Club, North Devon Motor Club, Torbay Motor Club, Windwhistle Motor Club, Ross & District Motor Sports Ltd, and registered contenders in the 2015 R.E.I.S. A.S.W.M.C. Classic Trial Championship who must hold a MSA Clubman's Licence
5. All competitors must produce a valid Club Membership Card and current MOT certificate, and championship contenders must produce a valid M.S.A. Competition Licence.

Passengers under 16 years of age will not be deemed competitors for the purpose of licenses and Club membership and will not be required to sign on. They will however, be required to produce a letter of consent from a parent or guardian at signing on, and this letter will be retained.

Any competitor or passenger under the age of 18 will be required to produce a letter of consent from a parent or guardian at signing on, which will be contained.

Any passengers who occupy the rear seats of saloon cars must be not less than 2 years of age. H. Chart 7/T.4.1.5/T.4.1.6. Any child under 12 years of age or 135cm in height must be seated using an approved "Child Restraint".

No passengers under the age of 14 shall be carried in an open car T.4.1.8

Classes D,5,4. Scrutineering starts at 8.00am, sign on by 8.30am, start 9.00am.

Classes 3,2,1. Scrutineering starts at 8.30am, sign on by 9.00am, start 9.30am.

Classes 6,7,8. Scrutineering starts at 9.00am sign on by 9.30am start 10.00am.

Any competitor not signed on 30 minutes after their scrutineering start time, may be excluded. Cars will start at 1 minute intervals.

6. Public roads will not be used to link sections. There will be at least 14 sections/tests within Cardinham Woods. Details of sections/tests will be issued at signing on. Marker posts will help define sections and any markers or back markers hit by a competing car will be deemed to be the point of failure, if seen by the marshals who are judges of fact.

7. The event will consist of nine classes as follows:

D) Sidecar Outfits.

1) Front engine, front wheel drive production cars (except vehicles in Class 6)

2) "Production Cars" built prior to 1941 including post war cars as per current MCC technical regulations.

3) Front engine, rear wheel drive Production Saloons (except vehicles in Class 6)

4) Rear engine, rear wheel drive Production Saloons up to and including 1300cc (except vehicles in class 7)

5) Front engine Production sports cars (except vehicles in Classes 1 & 6)

6a) Rear engine, rear wheel drive Production cars (except vehicles in class 4)

b) Front-engined Production cars fitted with torque biasing differentials as standard equipment.

7a) Production cars modified beyond permitted limits

b) Rear engine production cars fitted with torque biasing differentials as standard equipment.

c) Front engine cars manufactured on a limited basis conforming to accepted specification. These cars comply with either or both of the following.

i) Have the rearmost part of the front seat cushion(s) forward of any part of the rear tyres

ii) Have a wheelbase of 90" (228.6cm)

8a) Non production cars.

b) Rear engined cars (except vehicles in classes 4, 6, & 7.

c) Front-engined cars manufactured on a limited basis (except those in Cl. 7 including those which: 1.) have the rearmost part of the front seat cushion(s) rearward of any part of the rear tyres and 11) have a wheelbase of less than 90", (228.6cm)

8. The Awards will be presented as follows:

The Cotswold Trophy to be held for 11 months and replica to the best performance on Class Index.

Class Win awards to the first in each class (excluding. the winner of the above)

First Class award subject to 5 starters per class.

Second Class award subject to 9 starters per class.

2nd second Class award subject to 12 starters per class.

2nd First Class award subject to 16 starters per class.

Novice award subject to 3 novice starters, on class index.

Award to the best lady, subject to 3 lady starters, on class index.

No person shall win more than one award. Points will be awarded towards the Driver under 21 years of age trophy, Gerald Thomas Trophy, Brian Rabey Electrical Trophy, Stan Cox Memorial Trophy, Brewer Cup and the Camel Vale Car Trophy, to be awarded annually.

Please note: Overall award will be determined by the index of Performance method i.e. the best five scores in each class are used to determine the average.

9. The entry list opens Thursday 1st. October and CLOSES FINALLY on Saturday 24th. October 2015. The entry fee is £30.00 per car. All entries must be made on the official entry form and accompanied by the appropriate fee. NO ENTRIES WILL BE ACCEPTED ON THE DAY. Please enclose a large stamped, addressed envelope, first class, for results, or a readable email address. The Secretary of the Meeting to whom all entries must be sent is:

10. The maximum entry for the meeting, including reserves is 80. The minimum is 26. The absolute minimum for each class is 3. Should any of the minimum figures not be reached, the organizers have the right to cancel the meeting or amalgamate the classes as required

11. Entries will be selected as follows: strictly by reverse order of receipt in each class. Entry fees will be refunded in full if notification of cancellation is received by the closing date. Cancellation after the date will receive £15 refund.

12. Other officials are: Stewards: **CARS, TREVOR ANNEAR. OUTFITS, JOHN YOUNG**

Clerk of the Course: **SIMON GROVES.**

Scrutineer: **PETER COMBELLACK**

Chief Marshall: **ROY HARTLEY.**

13. Any car that drops more than 30 mins behind the last class to start will be deemed to have retired.

TO BE CLASSIFIED AS A FINISHER YOU MUST SIGN OFF AT THE FINISH VENUE within 45 minutes of the last car finishing the last section. Any person not signing off will not receive any awards due, but their scores may be used in formulating results

Provisional Results will be announced as soon as possible after the event.

14. Any protest must be lodged in accordance with 2015 MSA 'Blue Book' Section C

15. Competitors will be identified by numbers issued at signing on and must be handed in at signing off or upon retirement.

16. Practicing will not be allowed at any time and any competitor found doing so, will be excluded.

17. For this event, each class will be designated a travelling Marshal whose duty will be to report to the Secretary anyone who disobeys instructions within the regulations for this event, i.e., speeding, parking, noise etc. Penalties for infringement will be as written.

18. Marking and penalties will be as printed in the appropriate section of the MSA General Regulations. All other General Regulations of the MSA apply

19. A minimum tyre pressure may be imposed by class or by section as announced on the route card.

20. Competitors will run in class order and must as far as possible remain in numerical order throughout the event. Classes will run in the following order D,5,4,3,2,1,6,7,8. NO DOUBLE DRIVES ALLOWED.

21. No vehicles will be allowed to carry any advertising material except for club or championship decals up to a maximum of 55sq. in. Competitors are reminded that advertisements covered by paper and/or tape, are not acceptable. Any vehicle whose appearance or condition is below standard appropriate to the event will not be allowed to start. Fire extinguishers to a level of safety specified in K.3.1.1 are mandatory i.e. a small hand operated AFFF 1.75 litre unit. All competitors must carry a spill kit complying with J.5.20.13. *Absorbent pads and granular absorbent materials capable of dealing with spillages up to 1.25 litres capacity. These will be available to purchase at signing on for a very reasonable sum of £5.00*

22. As the event takes place on private land, insurance is not required. However, once the competitor leaves the forest, they will be deemed as having finished the event for insurance purposes.

23. Any competitor involved in an accident must make a written report to the Secretary at signing off or within 7 days of the event if a non-finisher.

24. Conditions for the use of the land are: **(a) NO SMOKING. (b) MAXIMUM SPEED LIMIT OF 15MPH. PENALTY EXCLUSION FOR EITHER.**

25. Marshals will be needed. Please phone Chief Marshal, **ROY HARTLEY on 01208 75562.** Marshals draw to take place at finish venue. Prize - 2016 membership.

26. This event is becoming more difficult to put on as more and more people are using the forests. **PLEASE TAKE NOTE OF ALL THE ORGANISERS REQUESTS.** Our future depends on your compliance.

27. The finish venue is the Borough Arms, Dunmere Road, Bodmin. Depart from the woods at point of entry and turn right, continue along to A38 roundabout where right. In, ¼ mile, right at roundabout. Straight on at Morrison's roundabout. Right at next roundabout and follow the Ring Road through Bodmin turning right at the 2 mini roundabouts. Continue and down hill for 1 mile then turn left into pub car park. **PLEASE NO MUDDY BOOTS INSIDE.**

28. BECAUSE OF THE TREE FUNGAL DISEASE THIS EVENT IS TAKING PLACE ON A WING AND A PRAYER. ALL VEHICLES MUST BE PRESENTED FOR SCRUTINEERING IN A CLEAN STATE AND MAY HAVE TO BE PRESSURE WASHED OFF BEFORE LEAVING THE EVENT.

On March 10th 1982 Camel Vale Motor Club Ltd lost one of its staunchest members with the sudden death of Stan Cox, affectionately known as “Stan, Stan the chainsaw man” due to his overwhelming enthusiasm in clearing trials sections with his trusty chainsaw, mainly in the forests of Dunmere and Cardinham, close to where he was born and very close to his heart.

In memory of this great man his very close friends Gerald and Pat Thomas donated a trophy to be awarded annually and to be known as “The Stan Cox Memorial Trophy”. This award is presented to the best Camel Vale member on Index of Performance basis on the results of the two forest trials, the Camel Heights in March in Dunmere and the Bodmin Trial in November in Cardinham.

The Stan Cox Memorial Trophy will be awarded on aggregate index of performance figures for both events.
