1) North Devon Motor Club are organising a classic reliability trial on Sunday 17th November 2017. Starting and finishing at the Cedars Inn, Bickington Road, Sticklepath, Barnstaple. EX31 2HE: MR 180/539325. This event is organised under an Open ACU permit, all competitors will require an ACU Trials Registration (riders & passengers) or apply for 'One event Trial Registration' at £3.00 per person from the club – see entry form..

2) The meeting will be governed by the general regulations of the ACU ACU permit: 51651 DOE Authorisation: 27905NO19

3) This event is a round of the 2017 ACTC motorcycle championship: Round 13 of the Red Rose Bowl, and round 13 of the Pouncey League.

5) The event is open to: ACTC. Motorcycles & combinations who are affiliated members of the ACU. Appropriate licences are necessary.

6)Insurance: This is covered by the ACU via the permit.

CLASSES

7) The event will consist of seven classes, plus novices.
A British motorcycles pre 1965 (engine & frame)

B1 Solo motorcycles up to 225cc
B2 Solo motorcycles 226cc up to 450cc
C Solo motorcycles 451 cc and over
D Motorcycle Combinations
E Other three wheeled vehicles maximum 1300cc
X Any solo or combination motorcycle which has a wheelbase less than 1320mm.

ENTRIES

8) Entries open on publication of these regulations and will close on 11th November 2017

The entry fees are: £30.00 for all classes. The minimum entry is 30 which if not met we reserve the right to cancel the meeting. Classes will not be amalgamated.

9) Basic details will be entered and kept on computer for internal use for NDMC and the Steve Knight Tarka Trial, and ACTC championship secretaries only.

10) All entries, correctly submitted, are deemed **to be accepted**, unless we write by return to the contrary. Entries withdrawn in writing before the closing date will receive a refund less £4.00. Entry lists, finals and the route instructions will be sent to all competitors 5 days before the event. All competitors must have applied on the official entry form and enclosed the fee made out to North Devon Motor Club + two 1st class stamps OR by Email.

SCRUTINEERING

11) Scrutineering will start at 8.00am at Cedars Inn map 180 / 539325 in order as advised in final instructions and on the day. All motorcycles must comply with the 2017 ACU technical regulations for classic trials.

12) Vehicles must be taxed and insured and have a valid MOT certificate (if applicable) **for** the road, which must be shown to the Scrutineer. All must hold a normal RTA license, all bikes must have working lights. Noise levels will be enforced.

13) Sponsorship or advertising decals are not permitted on vehicles Any

financial benefit (by way of sponsorship) is also prohibited, so as to maintain the amateur status of trialling in general.

14) Gas bottles must be securely fixed.

15) Tyres must be inflated with a tread depth not exceeding 13mm. The main tread blocks must be uniform in depth and be in line parallel or at right angles only to the wheel axis – they must not exceed 13mm in circumference or 9.5mm in width. Spaces between the main blocks must not extend across the full width of the tyre i.e. a block must interrupt the space. Spaces between shoulder blocks must not exceed 22mm.

16) Three wheeled passengers must be seated side by side and have a substantial; preferably metal floor, and be surrounded by sides at least 12in high.

SIGNING ON

17) After scrutineering (at Cedars) all must produce the pass form at signing on, along with a valid ACU Trials Licence, plus an affiliated **club membership** card. Please sign the ACU Competitors 'Signing On' sheet and please remember to sign the insurance declaration.

18) Identifying numbers will be provided and must be fitted throughout the event.

19) You must have signed on at least **20 minutes before your start**. Order of starting will be D, A, B, C, E, X or as advised on the day. 1st vehicle will start from Cedars Inn at **09.00am** - then at 1 minute intervals.

THE EVENT

20) Competitors who view the sections in advance will incur 6 penalty points.

21) At restarts **stop** astride the (imaginary) line / post & wait for the flag to be raised.

22) Marking and penalties will be as stated in ACU regulations and all

hills will be sub-divided with penalty posts numbered 12–1 some sections will contain a re-start, this will be notified in your route instructions. There will be no re-starts for class A and D.

23) Please keep to your **due time**. Those that hold back or fall behind by more than ten minutes of the preceding vehicle, may be refused that section. We must run to time.

24) Any vehicle overtaken by the course closer, must make up time or short cut, or they are deemed to have retired

25) Any competitor whose conduct is unsatisfactory, will be excluded.

26) Any competitor involved in any incident must report this to the Secretary of the Meeting at 'Signing Off' or in writing within 72 hours if retiring early. All must sign the damage declaration.

27) Provisional Results will be sent out within **5 days of the finish of the event** and will become final after a further 7 days

28) Awards will be at organisers discretion.

3) The event is open to **Cars: National B**; all fully elected members of the organising club and members of member clubs of the ASWMC and ACTC, **Clubmans**; The event is open to all elected and fully paid up members of the NDMC and to members of MCC, VSCC, Ross & District MSC, Falcon MC, Bristol MC, Stroud & District MC, MG Car Club, Fellside AC, Holsworthy MC, Liege Car Club, MAC, Minehead MC, Hagley & DLCC, Windwhistle, Woolbridge MC. The driver and passenger must produce a current club membership card.

4) All drivers in the National B event must produce a valid MSA Competition Licence. All **drivers** and **passengers** must produce a Club Membership Card, Championship Registration Card (where applicable) for inspection at signing on. 1 Front engine, front wheel drive production saloons, (except class 6)

2 Cars manufactured prior to 1941. plus also MGTC Morgan4-4 HRG 1100 & 1500 Ford E04A E494A E4930A/B E93A E493A 103E + upright to 1959

3 Front engine rear wheel drive production saloons. (except class 6)

4 Rear engine, rear wheel drive production saloons up to 1300cc (except class 7)

5 Front engine production sports cars. (except class 1 and 6)

6 Rear engine, rear wheel drive production cars. (except class 7) plus front engine production cars fitted with a torque biasing differential (LSD).

7 Rear engine production cars fitted with LSD plus cars modified beyond permitted specification. plus front engine cars manufactured on a limited basis with a wheel base of 90in (228.6cm) or greater, and/or have the rear most part of their seat cushion forward of the rear tyres.

8 Non-production cars, plus cars (except 4, 6, 7) manufactured on a limited basis to include those that have a wheel base less than 90in (228.6cm) and / or have the rear most part of their seat cushion, rearward of the rear tyre.

10) All entries, correctly submitted, are deemed **to be accepted**, unless we write by return to the contrary. Entries withdrawn in writing before the closing date will receive a refund less £4.00. Entry lists, finals and the route instructions will be sent to all competitors 5 days before the event. All

competitors must have applied on the official entry form and enclosed the fee made out to North Devon Motor Club + two 1st class stamps OR by Email.

SCRUTINEERING

11) Scrutineering will start at 8.00am 17th Nov. 2017 at Cedars Inn map 180 / 539325 in order as advised in final instructions and on the day. All vehicles must comply with the 2017 MSA technical regulations for classic trials.

12) Vehicles must be taxed and insured and have a valid MOT certificate (if applicable) for the road, which must be shown to the Scrutineer. All must hold a normal RTA license. All vehicles must have a towing eye and strap (ropes are no longer recommended) and must carry a spill kit and a fire extinguisher visible & accessible. Tyres as per ACTC list. Battery earth strap identified. Body work enveloping all mechanical components. Noise levels will be enforced.

13) Sponsorship or advertising decals are not permitted on vehicles. Any financial benefit (by way of sponsorship) is also prohibited, so as to maintain the amateur status of trialling in general.

14) Gas bottles must be securely fixed and kept within the confines of the vehicle.

SIGNING ON

15) After scrutineering all must produce the pass form at signing on. All **National B** drivers must produce a valid MSA competition license and current club membership card. All **Clubman** drivers must produce a current membership card from an invited club. All passengers must produce a current membership card. Please sign on to the MSA Competitors Signing On sheet – and remember to sign the insurance declaration form.

16) Identifying numbers will be provided and must be fitted throughout the event.

17) You must have signed on at least **20 minutes before your start**. Order of starting will be 8, 7, 6, 1, 2, 3, 4, 5 or as advised on the day. 1st vehicle will start from Cedars Inn at 09.00am - **then** at 1 minute intervals.

Nearly all hills will be sub-divided with penalty posts numbered 12–1 some sections will contain a re-start, this will be notified in your route instructions. There will be no re-starts for class 1.

22) Please keep to your **due time**. Those that hold back or fall behind by more than ten minutes of the preceding vehicle may be refused that section.
