"Replacement QK 2.7.4.

- i) In all classes, spare wheels must be firmly secured by a permanent fixing. Not more than 2 may be carried externally and must be fitted as close as possible to the bodywork on the rear bootlid (or equivalent) or in a purpose made carrier. Unless otherwise officially specified, the spare wheels of the carrier must not extend more than 200mm beyond the extremity of the original bumper position for the model of the vehicle.
- ii) Cars with an external rear mounted wheel in the manufacturers standard position may add a second, mounted flush with the original spare wheel with no spacer.

iii) Wheels must not be mounted on the roof of any vehicle.

iv) Wheels must not be mounted on the front bonnet (unless specified by the manufacturer) or in such a manner as to obstruct significantly forward visibility of the driver from the normal seating position. Wheels mounted on the front of vehicles must be secured so that no part of the fixing is beyond the tyre."
