MATTERS ARISING FROM MINUTES OF 10/4/94 OTHER THAN DETAILED IN THE AGENDA

Simon asked Richard Dawe to scrutinise the regs for Trials when they arrive with him and ask Clubs to include Class 2 changes.

ELECTION OF PRESIDENT AND VICE PRESIDENTS

The Chairman suggested that this should be postponed until the September AGM to which Council agreed

ELECTION OF HONORARY OFFICERS for commencement of duties at September AGM

All officers except the Hon Secretary stood for re-election. Holsworthy proposed a block vote for all those standing for re-election. SODC seconded, all re-elected unanimously as follows:

For the post of Hon Secretary there were two nominations: Stephen Bailley (Proposed: Shenstone, seconded: Bristol MC) Gerald Burridge (Proposed: MGCC, seconded:Launceston)

It was proposed by Launceston that voting should be carried out on voting slips, seconded by MCC and agreed.

The Gerald Burridge and Stephen Bailley left the room and voting took place. Votes were cast in equal numbers for the two Candidates. The Chairman used his casting vote and Gerald Burridge was duly elected. On the candidates return to the meeting, Simon thanked them both for standing and asked Stephen if he would take on the task of Class 7 co-ordinator. Stephen agreed.

FINANCIAL REPORT (JANET MATTIN, TREASURER)

Janet reported that she was having to chase Clubs for their subscriptions. Roger Pole apologised for Holsworthy and said he would make sure payment was forthcoming; Alan Foster said the same on behalf of Morgan Sports Car Club. No delegate for Torbay was present and Janet reported that they were also in

arrears. The Council agreed that Janet should ask for payment by 30/4/95 or Torbay would be deemed not to be members of ACTC. There was some discussion as to what the rules are on this matter and how it would affect the Championship.

NEW CLUBS APPLYING FOR MEMBERSHIP

Anne Templeton (Secretary) reported that West Cornwall Motor Club had dropped their application for the time being.

Falcon Motor Club and Newquay Motor Club were both applying for membership

Falcon MC: Holsworthy proposed, Ross seconded; Falcon were unanimously elected to ACTC

Newquay MC: MCC proposed, Woolbridge MC seconded; Newquay were duly elected to ACTC (1 abstention)

REPORT FROM SIMON WOODALL ON THE WORK COVERED BY THE RAC MSA TRIALS COMMITTEE

Simon Woodall reported that one of the items discussed had been methods used for Index of Performance. Simon asked Camel Vale and Launceston if they had any opinions on the subject as they both used Index of Performance to score their Trials. Robin Moore (Launceston) said he liked the present system. Hans Viertel (Camel Vale) said he preferred the old method.

Discussions had also taken place regarding LSD's and whether FWD cars fitted with these as standard should run in Class 3. Simon said the RAC were not happy with piecemeal changes to class structures. Alan Foster, MCC delegate to the Trials Committee explained that the RAC felt changes to the Blue Book should only be made after being tried and tested.

Roger Pole (Holsworthy) inquired where the proposal had come from as it had not been discussed or voted on at an ACTC Council Meeting. Simon apologised to Council for the fact that he had gone along with the MCC's proposal without the ACTC council's prior sanction. He explained that he thought that the matter had been discussed and voted on. Bristol MC asked why ACTC should consider LSD's and traction control at all. Alan Foster explained that the reasoning behind, the idea was that as rear whhel drive cars were becoming rarer, perhaps the time had come to encourage FWD cars with standard fittings. Simon Woodall pointed out that in the future, most production cars would have traction control fitted as standard equipment. SODC observed that traction control would not be of much benefit on a Classic trial. MGCC agreed as most systems closed the throttle to prevent wheelspin. Launceston said that handicapping was a better way forward. There was much discussion on the points raised. Roger Pole (Holsworthy) suggested that the classes should be left alone and when any of these cars began to compete, the sistuation should be carefully monitored and any decision should be made in the light of their apparent performance.

The Chairman wound up the discussion by asking Clubs to discuss this with their members and come back in September with firm proposals.

TO DISCUSS APPOINTMENT OF ROW OFFICER AND ROW MATTERS ARISING FROM PREVIOUS MEETING.

The Secretary distributed documentation received from Peter Colman (Ilkley) which aked for Clubs to respond to the Environment Bill currently going through Parliament. He had requested that Clubs do respond as time was getting short

Proposal was passed (1 abstention).

CHAMPIONSHIP REPORTS

a) Championship Secretary/Scorer Richard Dawe Copy of Accounts and Championship Tables attached.

There was a request that the Regs should be publishe earlier this year, Richard said that this was in hand. There was a also a request for the Form to be on a separate sheet, it was agreed to do this.

b) Championship Quality Controller Andy Webb Copy attached.

Andy Webb reported that he had some reservations on the Ilkley being included in the Championship as there had been some adverse comment from Observer's Reports. The Clee Hill had been very favourably commented on and he felt this should definitely be included.

After some discussion Sheffield MC proposed that the Ilkley Trial be included in the Championship for 1995; seconded Launceston. The proposal was carried (3 abstentions, 2 against).

Holsworthy proposed the Clee Hill Trial be included in the 1996 Championship; SODC seconded, proposal carried unanimously.

Andy concluded his report saying that Clubs should not assume they will be included in the Championship automatically. If the standard drops too far, tehn they should be suspended from the Championship until standards are seen to improve. The Chairman agreed and said that Clubs should look to their laurels. There was some discussion as to the best method of choosing the Trial of the Year Award. The Secretary said that post cards were being printed for sending out with the results. It would then be up to the competitors to send them back.

Simon Woodall asked for any good ideas on the matter.
