1. Apologies for Absence

2. Election of Officers

All officers elected at the May meeting. The new vice-chairman Brian Partridge was welcomed.

3. Minutes of Previous Meeting on 9th May 2010.

Were accepted. Proposed, Ross, Seconded, Vice-chairman.

- 5. ACTC Club Membership No new Clubs

6. Financial Report

- 6.1 The Budget for 2011 was reviewed by the treasurer. See **Attachment 1**.
- 6.2 It was decided not to buy the Up-lights for after dark scrutineering.

7. MSA Trials Committee Report

- 7.1 Spill Kits. Simon Woodall displayed a typical small spill kit, it was the size of a small cushion. It is hoped that smaller kits can be sourced and used. The requirement for competitors to carry a spill kit has been postponed until 2012 and the supply by organisers is postponed until we hear otherwise.
- 7.2 Event Grading. There was a long discussion on how ACTC clubs can run their events at Clubmans level to negate the use of a competition licence but still being able

to have competitors register for the championship. Clarification is required from the MSA.

Action: Simon Woodall

It was proposed that **all** ACTC championship events in 2011 are run at NB status. Proposed, Ross, Seconded MAC, Passed unanimously.

7.3 Marshals as Judges of Fact. Currently only 'Officials' can be Judges of Fact. There were suggestions of making Marshals Officials. The general feeling was they should stay as Marshals.

8. Technical Matters

8.1 Wheel Diameters. There was discussion on wheel diameters generally as the Adrian Tucker-Peak letter circulated with the agenda. The meeting was in agreement to allow smaller diameter wheels. This should be in place for 2012.

Suitable wording was required for the 'Blue Book', possibly that matches the Car Trials events.

Action: Simon Woodhall & Dudley Sterry

- 8.2 Quaife Differentials in Class 1. This was discussed at the last meeting and delegates had taken it back to clubs for further discussion. Camel Vale reported on a detailed poll that had been taken at a club meeting. There were four options to vote on and the options and votes received were as follows:-
- 1) ATB differential to be used in Class 1 only. 1 vote
- 2) ATB differential to be used in all Classes. 3 votes
- 3) No ATB differential to be used in any Classes. 4 votes
- 4) ATB differentials to be used in Class 1 as a trial for 12 to 18 months with a view to using it in all classes. 17 votes.

It was then proposed that Quaife/Torque Biasing Differentials should **not** be allowed in Class 1.

Proposed, Launceston & North Cornwall, Seconded, MCC, Motion carried 9 for and 2 against.

- 8.3 Splitting Class 1 at 1400c.c. Generally agreed that this was **not** a good idea and this will not happen. Concern was that any attempt to make this an attractive class for novices would be negated by the prospect of an 'expert' building a car to match this class's requirements.
- 8.4 ACTC Differential Test Machine. There were various statements on how effective the machine was. It was used on the Taw & Torridge Trial and worked well with cars that had tyres inflated to road pressures. Agreed to continue testing the machine.
- 8.5 Change of Regulations to Incorporate the Diff. Test Machine. We are not ready to change the regulations yet.
 - 8.6 Stroud & Dist MC Papers and Visit by Pete Hart and Simon Woodhall.

Carl Talbot has been invited to join the ACTC Technical Panel as a representative of Stroud & District MC.

The decision that Type 9 gearboxes can be used in Ford Escorts has been reviewed again by the ACTC Technical Panel and the decision **stands**.

Engine replacement The proposal to restrict engine changes to 'period' was discussed and passed back to the clubs for further discussion.

For Class 7a modified production cars a 'points' system was agreed and we should go forward with developing a 'points' system.

Proposed, Camel Vale, Seconded, MGCC, Motion passed unanimously.

Action: Pete Hart & Simon Woodhall to develop points system.

9 Handicapping.

Jonathan Toulmin was thanked for his paper on handicapping. It was unanimously decided not to take handicapping any further.

13.1 Remaining 2010.

Woolbridge MC will run The Hardy Trial on Nov.14th as a non-championship event. The Camel Classic will be a reduced event running in 3 adjacent forests due to the tree disease (sudden oak death) rife in the south-west.

13.2 2011 ACTC Schedule Draft 1 is available, see **Attachment 2** It has now been agreed that the ACTC events calendar will now be known as **The ACTC Schedule** to prevent confusing it with the ACTC Calendar, which Pat Toulmin sells to members.

14. Championship Reports

- 14.1 Car Championship. There are 136 drivers and 19 navigators registered for the championship. Chris Phillips gave the position in the latest Crackington, Wheelspin, Navigators and Team championship positions. The Team championship is very poorly supported again this year.
- 14.2 Motorcycle Championship. Stephen Bailey provided an extensive report on the championship and motorcycle business in general. Please refer to **Attachment 3** It was decided for 2011 to try the points scoring for starting and finishing an event, including MCC events for motorcycles only.
- **15. Championship Quality.** Dave Haizelden has sent out some Trial Quality Report forms for the Taw & Torridge Trial. Dave also plans to send Report Forms out as an attachment to the results. Thus all competitors on eMail will be able to comment on a trial. In addition he will have a panel of regular competitors who will report back to him when they are 'out'.



All so far with the exception of the Northern Trial ran the Approved class structure. They for some as yet unexplained reason put all the bikes including the sidecars into Class 0.

I trust they can rectify this for next year.

It is also noted that quite a few clubs have split the Class B entry into B1 & B2 I am hoping that this will continue.

Only seven of the ACTC member clubs as yet have a link into the ACTC web site.

Again I am requesting that the remainder of the clubs including the MCC put this link in as without any publicity the numbers may drop again next year.

I also asked last year for all clubs to put an ACTC membership form out to their members and I stated that I would print these off for any club that requested them. Again I will do this for this year.

In the past it has been suggested that Trials are getting harder and again there is the fact that clubs should not lay out sections to please a small number of expert competitors. It is much harder to control a bike going downhill and getting into and out of (or down from) some sections is difficult sometimes extremely difficult.

So I ask again please do not put special bike only routes and sections in or only if it really is an easy detour and safe. The main reason motorcycle competitors enter the ACTC series, is that the sections are suitable for cars and bikes.

Also not so many restarts, particularly steep ones. Cars just sit there with their wheels spinning. Motorcyclists invariably fall off and this can lead to injury. We still need to attract more motorcycles into the sport.

There are other trials for experts to compete in if they want. The rest of us are up for a good day out.

As for adding a point for entering a trial and a point for finishing this has had no effect on the position of the league tables so far this year.

So this scoring will be included for the motorcycle championships in 2011.

Also the Motorcycle solos Class B, will be split into B1 and B2. Which it will hope make a more closely run championship.

Good to see the Tarka Trial offering discount to e-mail instruction and route entrants.

I would also like to see the Regulations go out a bit earlier with a longer entry time and also the route posted out and e-mailed out at least 10 days before hand to give competitors time to sort things out.
