8. MSA Trials Committee Report

- **8.1 Spill Kits**. The requirement to carry a spill kit in every competing car has been ratified. No spill Kit = No Start. Kits will be available to purchase at scrutineering on ACTC events
- **8.2 Insurance**. Bill Bennett has had difficulty finding any insurance which confirms (in writing) its coverage of Classic trials. Adrian Flux policies are said to do so but are not entirely specific in writing.
- **8.3** Class 1 differentials A rule allowing Class 1 cars to make use of fully free differentials which had been made by recognised manufacturers from LSD differentials (currently forbidden) is being drafted.

The sentiment of the meeting was that this should apply to all classes and wished the topic to be taken back to the MSA Trials Committee for suitable amendment.

9. Technical Matters

9.1 Differential Test Machine (DTM). After some discussion the meeting felt that a system needed to be developed for the DTM to be transported to the various trials. In addition it is necessary that for safe siteing, a clear set of instructions is required, together with a suitable set of written operating instructions.

There were no volunteers for either of these tasks and both requirements are to be publicised through the Clubs and the ACTC website.

9.3. 'Modified Beyond' Scoring Scheme A draft of the proposed scoring system was circulated for discussion. The meeting decided that the general direction of the scheme was suitable and it was proposed that Pete Hart produces a written proposal which will be discussed at the May 2012 meeting.

The Restart editor, Pat Toulmin, has assembled an extensive collection of Restart's forerunners, 'Wheelspin' and 'Four Wheels Out' and suggests that these be bound and then archived. The Jan 84 and April& July editions of Wheelspin are missing and help is sought to find copies. It was agreed that the magazines should be archived, subject to the costs involved being passed to and approved by the Treasurer. Three quotations had been received as follows.

New Leaf Bindery, Birmingham. £35 to £40 per volume.

The Binding Place, Worcester. £15 for Wheelspin, £18 for Four Wheels Out (per volume) There are 8 volumes of Four Wheels Out and 4 volumes of Wheelspin. At The Binding Place this would be £204. 14. Championship Reports

14.1 Car Championships. Were summarised by Chris Phillips.

There was a wide ranging discussion covering the current reduction in entries to individual trials, those joining ACTC as competitors and the shortage of young competitors coming forward. It was thought that there were likely to be a multiplicity of causes for the reductions and thus no one single solution.

The Championship Secretary suggested that a form of Class'0' series might address some of the aspects of all three and was actioned to write a paper on his suggestion for circulation before and discussion at the May 2012 meeting.

- 17.2 The Association scrutineer (cars), John Blakely(JB), made a number of points:
 - a) the original plan for having a series scrutineer for cars envisaged the person being in addition to, not instead of, club scrutineers All too often the latter situation happens. This point needs to be reinforced with the organising clubs, especially in the light of b) below.

Action: All Clubs

- b) JB is now an MSA qualified Environmental scrutineer and has the necessary equipment and training to carry out accurate noise tests. However, if these are to be carried out at the start clearly JB cannot do both jobs.
- c) As from 1st Jan 2012 for noise tests carried out by JB, breaches of the regulation noise level will be entered on the scrutineering card and treated as any other scrutineering failure.
- **17.3 Morgan Three Wheelers**. The MTWC is not currently an MSA club but were recommended to change this as this would then allow pre 1941 three wheelers to compete in car only ACTC events in Class 2.



RIGHTS OF WAY REPORT Attachment to Agenda item 10

After several years of having "Nothing to report" there has been a flurry of activity in the past few months. Not all the items are strictly rights-of-way matters but, as they concern access to land that we use for our events, I think it is worth reporting them here under this heading.

14/28 Day Rule under threat

- In June 2011 the Department for Communities and Local Government published an "issues paper" entitled "How change of use is handled in the planning system tell us what you think".
- One of the "issues" concerned what is known as the 14/28 Day Rule. This permits the temporary use of land, without planning permission, for a number of activities. For motorsport the permitted development rights are limited to not more than 14 days in total in the calendar year. The DCLG questioned whether this temporary use, without permission, was still appropriate.
- LARA responded immediately and organised a robust defence of maintaining the current status quo. Although there has been no official statement from DCLG since the end of the consultation period, I understand that LARA are quietly confident that the matter will "go away" for the foreseeable future (it was last raised in 2002 after which it disappeared for the intervening nine years).

Government Forestry Review Panel

- In July 2011, the MSA organised a nationwide campaign in response to a perceived threat to the continued use of forests for motorsport. The response from motor sport enthusiasts exceeded everyone's expectations and we now await the results of the consultation process.

Threat to Burledge

- In June 2011, Bristol Motor Club were alerted that Bath and North East Somerset Council (BANES) were proposing to make a Permanent Traffic Regulation Order which would have had the effect of banning all motor vehicle use of the Byway that we know as Burledge.
- LARA responded to Bristol MC's request for help and a meeting was held on site at Burledge on 24th August. Attendees included representatives of BANES, the local police, LARA, and Bristol MC.
- LARA proposed a time-limited TRO, which would allow the continued use of Burledge by Bristol MC for the Allen Trial, and this is now being considered by BANES. The police, who were not familiar with the concept of time-limited TROs were extremely enthusiastic.
- Pete Hart may have more up-to-date information to report at the AGM.

Temporary closures for motorsport events

- Some local authorities (Gloucestershire is one that I know of) are threatening to require temporary closure orders where rights of way are "affected" by motorsport events requiring approval under Section 33 of the Road Traffic Act. The wording of the latest Gloucestershire Rights of Way Improvement Plan implies that these closures could apply both where the route of an event is along a right of way (which requires Section 33 approval but not, at the moment, a temporary closure) and where the route of an event crosses a right of way.
- My understanding is that the latter situation (where the route of an event crosses a right of way) is intended primarily for speed events, such as rallies and enduros, where organisers do not marshal every footpath crossing and there is the possibility of members of the public straying into the path of a speeding vehicle.
- Gloucestershire provides a neat get-out which allows a risk assessment as an alternative to the (expensive) temporary closure order.
- I do not believe that this is yet a major issue but trials organisers need to be aware that they may be asked for risk assessments wherever a right of way is used or crossed. Placing a marshal at the end of the section, and at any crossing, is an obvious solution but it is then imperative to ensure that the crew running the section are aware of these obligations.

Championship Places:

The Championships' are being reasonably supported and in the Red Rose Bowl Simon Eddy is in first place, Geoff Westcott second and Al Lidgate Third.

In the Pouncey league Stephen Kingstone Leading by some considerable margin, David Craddock Second, Andrew Craddock Third, Julien Slade Fourth and Buster Griffin fifth...

Other:

We have a new member Lloyd Barwick from the leaflets I put out at the MCC Testing Trial.

I also had an ACTC promotion stand at the Popham Mega meet.

I again ask the members of the committee to actively publicise the ACTC and if at all possible sent entry forms for 2012 to their members when they send out their own club membership reminders.

The Championship contenders were again contacted re the question of Side-car specifications.

I received no reply to my e-mails from the MCC, however a short reply from their championship secretary was "The MCC has republished its specifications the same as last year and they have not altered"....

The ACTC Red Rose Bowl Contenders were in agreement that the Specifications should stand and if Sidecars were entered in a championship round that were not as required then they should be put into a separate class or not run. The onus on the organising club to police via there scrutineering.

As regards to Motorcycle lights being required again the census of opinion was that Lights should be required, However it would be up to the organising club to state this or not in its Regulations for the event and up to the organising club to police via their scrutineering.

In the case of vehicles without lights, they must stop, if conditions are such that lights would be required by law.

So the advice from the ACTC should be that light are required unless otherwise specified.

Championship Proposal

What follows, started off as a championship proposal to encourage more ACTC memberships and interest in the competing in a championship. As I've given it more thought, it has evolved as a group of ideas with differing merit, but hopefully will serve as a good discussion point at the meeting. DW

Introduction

In recent years The ACTC championship has fallen with it being contended seriously by probably only 20 or so competitors nationally each year. In times gone by joining the ACTC was a sure-fire way of getting the regs posted for each event. Whilst this is still a draw the regs for each event are now easily accessible online so the perceived 'value for money' aspect has been a little diminished.

Whilst very few now compete in a 'full season' of trials there are quite a few who compete in the MCC's plus 1 or 2 local events each year.

Proposal

This proposal is that the ACTC consider running a mini championship. Any member competing in 5 or less events during the year would be eligible, those competing in more than 5 events would automatically be 'bumped' into the main Wheelspin and Crackington championships. Qualifying events could be the best 3 scoring events from all the ACTC rounds, with a maximum of 2MCC rounds counting.

Scoring

I'm unsure exactly how to tackle this. Certainly the existing system has been used (successfully?) for a good few years, but I must admit it leaves me confused most of the time (and I am aware this is felt by some others also) and *maybe* a contributing factor lack of 'contenders'. In addition it may not help with attracting 'contenders' from the smaller classes.

e.g.1. Bill, John Bell and myself enter a trial as the only class 2 cars. I have the trial of my life and win the class – result 10.3pts (I think!?)

e.g.2 I enter the Dellow in the same trial, (busy class 8 that day) the trial suits big wheels (Dudley is hasn't entered) I do ok and win the class – result 10.11 (I think!?)

The current system works on the basis that the more in the class the more difficult it is to win. Understandable, but in most classes, we have the select 3 or 4 who are likely to contend a class win and the rest as 'possible outsiders' so in reality I'm not sure the size of the class makes all that much difference?

A simpler integer system might help to attract some other members who have not considered the championship before. Rather than a 10 - 0 system why not have a 25-0 system with smaller gaps towards the top positions that gradually increase, and makes it easier to catch up?

Unfortunately though, some poor soul has to work all this out and running two parallel scoring systems is probably totally impractical!?Unless members register for the Mini Championship rather than the main championships???
